1. Description of Offense

On June 26, 2023 I, Major Joshua C. Brinson, was requested by the Detectives to make contact with Patrick Scott reference this incident.

I located Scott at the Manilla Mini-Mart. He was sitting in his truck. I exited by vehicle and approached Scott in which he exited his truck. I had my body camera activated. The following are details from our conversation and may not be word for word.

Scott initially stated that he last heard from JV the Tuesday before the Wednesday that JV left. Scott stated that he does not know where JV is located. Scott stated that he has not seen JV's car.

I informed Scott that JV's car has been located. I informed him that it is believed that he may be assisting JV. I informed him that it is believed that JV was with him the day that she went missing.

Scott stated that JV is not at the Berwick Apartments in Shelbyville. He stated that he does not know where JV is. Scott stated that JV asked him to park her car at the apartments. Scott stated that JV took off on Wednesday afternoon. Scott stated that the last time he saw JV was Wednesday.

Scott stated that JV was with him in the red Ford Taurus on Wednesday. Scott stated that he brought JV back to Homer on Wednesday. He stated that he dropped her off in Homer near the old garage and before the Sampler. He stated that he did not have her phone.

He stated that he did not take JV back to Arlington on Wednesday.

Scott stated that he took JV's car from South High Gardens (Shelbyville) and parked it at Berwick Apartments. He then walked back to his truck at South High Gardens.

He stated that he took the Ford Taurus to the South High Gardens Apartments a day or two before Wednesday.

Scott stated that he moved JV's car after he dropped her off in Homer.

Scott stated that JV met him at South High Gardens on Wednesday. He then drove her to Homer and dropped her off with a male subject. He stated that the male was driving a little blue car, unknown make and model. He stated he went home.

Scott stated that it appeared that the blue car left and went towards Rushville.

Scott stated that he moved JV's car on Thursday.

Scott stated that he remembers JV talking to a Brady and other male subjects.

Scott stated that JV did not tell him any plans other than she was living and not coming back.

I asked Scott to come with me to the Sheriff's Office for an interview.

I asked Scott to see his phone. He gave me his phone and stated it is the only phone he has. He stated that it was okay with him that I keep his phone until after the interview.

I then followed Scott to his residence where he could park his truck and trailer for security reasons.

I then drove Scott into the Sheriff's Office for further interviewing.

The following are details from this interview and may not be word for word.

I first advised Scott of his rights from the Waiver of Rights Form. He stated that he understood and waived his rights by signing the form.

Scott stated that JV lives in the residence in front of his residence and JV works for him in the summer mowing grass.

Scott stated that JV and him ride together to the job sites with the exception of 1 time.

Scott recalls when I stopped at his residence on Saturday, June 10, 2023 and asked him about this incident. He recalls stating to me that the last time he saw JV was Tuesday before the Wednesday she went missing.

Scott stated that the last time he saw JV was Wednesday afternoon (June 08, 2023). Scott stated that he met up with JV at South High Gardens in Shelbyville. Scott stated that he had the truck and car there. He stated that he drove the car there a day or two before because JV was looking to take off. Scott stated that he was not giving her the car to use. He stated that he was just going to give her a ride. Scott stated that JV told her a couple of days before that she was going to leave. He had the car there because he didn't want to use his truck and trailer.

He stated that he was at South High Gardens and JV arrived on Wednesday in her car. He stated that JV and him then left in his Ford Taurus. He stated that he left his truck and trailer at South High Gardens and JV's car was left there as well. He stated that they came back to Rush County. He stated that JV was using her phone. Scott thought they were going back to Rushville but JV had him stop in Homer. He stated that she then exited his car and got in to another car with another male subject. He stated that it was a pale blue car.

He stated that he dropped JV off near the old garage on the east side after he turned off of State Road 44.

Scott stated that JV took her phone. He stated that he could not see the male subject very well but it appeared that he was alone.

Scott stated that he then went to his house in Arlington.

Scott stated that he moved JV's car to Berwick Apartments on Thursday. He backed it in. He stated that he did not remove the license plate. He then walked back to South High Gardens to his truck.

Scott stated that he has not seen or heard from JV since Wednesday.

Scott stated that he communicates by calling and text.

Scott stated that the blue car turned like it was going towards

Rushville however he did not actually see the car turn one way or another.

I informed Scott about JV's location from her phone. I told him that it was shut off closer to Arlington and not Homer.

Scott stated that JV was not with him at this time.

Scott stated that he has not assisted JV but he stated that if she showed up a job site asking for money he would have given her money but she has not showed up.

Scott stated that he thinks JV has to be out of money because he knew how much she made the last two weeks that she worked for him. He stated that it would have been between \$900 and \$1000.

Scott stated that he only knows the name of Brady. He stated that this boy broke up with JV and she was mad about this. He stated that JV was going to get back with Brady so she could break up with him. He stated that Brady drives an orange car and he came to JV's house on Monday (June 06) to pick up his items.

Scott stated that JV had been discussing about leaving. Scott stated that he thought she was leaving Saturday night because she stated that she was leaving Saturday.

Scott stated that he only goes to the Berwick Apartments for work most of the time. I asked Scott if has ever been to Berwick without his truck and trailer. He stated no.

I then asked Scott about why he was in the area of Berwick on Friday in the Taurus. He stated that he did not know. Scott stated that he was in the area of Berwick. He later eventually stated that he was going to the apartments to check if JV's car was still where he left it.

He stated that he had been at Berwick twice since JV's been missing and knew the car to be there.

I informed Scott of his rights from the Consent to Search Form reference searching his phone. He stated he understood and gave consent to search by signing the form.

At this time I went through Scott's phone. I did not see any recent communication with JV or that appeared to be JV. I did take a photo of the last messages between JV and Scott.

June 07, 2023 at 11:23 AM
JV: I'll be there soon

June 07, 2023 at 05:40 PM
Scott: He where are you

June 08, 2023 at 02:46 PM
Scott: Hey call me please if you're afraid of your dad tell me and I'll go with you

I also looked at the photos and did not find anything inappropriate. I saw the last photo of JV in the phone and it was taken prior to June 08, 2023.

I asked Scott if he knew anyone personally at Berwick or South High

Gardens. He stated no.

I asked Scott how he paid JV. He stated that he paid her at the end of every day and pays JV \$120 to \$150 a day. He stated that he paid her everyday. He stated that JV worked for him on Monday and Tuesday and paid her the amount as stated. He stated that he did not give her any money on Wednesday or a large lump sum prior.

Scott stated that he does not know where JV is located.

Scott stated that he does not use Social Media.

I had Scott attempt to call JV from all the numbers believed to be hers without success.

I asked Scott if he knew a Chet. He stated that he knows Chet and that he lives in Berwick. He stated that as far as he knows JV is not at Chet's.

This concludes the details from this interview.

1. Description of Offense: During this investigation it was learned that the last sighting of JVs vehicle Indiana registered plate ZYK833, according to Flock Camera system, was June 7, 2023 at 12:21 PM in Shelbyville east bound on State Road 44, west of I-74.

Scott was spoken to on June 10, 2023 by Maj. Brinson at 2394 N Oak St, Arlington. Scott said he had use of a GPS tracking App(Live 360) for tracking JVs phone to be able to know where JV was and last knew that JV was at her home at 12:21 PM on June 7, 2023.

On June 16, 2023, I received a return of information in accordance with an issued search warrant for Snap Chat user ID: lil.badshawty. Of the information returned, Geographical location(Geo Loc) information giving longitude and latitude for pings to JVs phone. The term "ping" is used to indicate the location and time that GPS signal accessed the device used at the request of the user of the device, when service is used to send or receive data.

JVs Geo Loc was tracked to confirm that JV had driven to Shelbyville on June 7, 2023 as shown on Flock camera at 12:21 PM, and pinged at 12:36 PM at the intersection of Michigan St and Progress Parkway as indicated by time stamp and date of photo sent to Snap user gasfriendly and marshallphi2017, but did not pass any other Flock cameras past this time.

A review of Geo Loc pings continuing from 12:36 PM, indicated direction of travel was east bound back from Shelbyville following State Road 44 into Rush County, pinging at last know location at 12:53 PM, just north of 1231 N 725 W. On June 13, 2023, Detective Meek and myself conducted a search of the wooded property area of last known Geo Loc with no findings.

Continued investigations of the electronic data returned, as a result of Search Warrants issued to Facebook, Instagram, BMO Harris bank records, T-mobile, and Snap Chat for potential suspects or locations lead to physical searches of the Shelbyville, Arlington, and Rushville to exhaust possible leads known at this time ending thus far with negative findings.

A refocus on June 19, 2023 for Geo Locs ending back into Rush County caused efforts of focus back to the Flock camera system for the vehicle that should have passed our camera at SR 44 and 975 W. GEO Locs on June 7, 2023 pinging to JVs phone had a location that hit at 12:44 PM just east of rays crossing, east bound, and just prior to Rush County Flock camera, at 12:46 PM on SR 44 and 975 W. This image recovered is that of a maroon Ford Taurus, Indiana plate YCL854, registered to Michelle Scott of Arlington.

It was noted from this photo recovered by Flock on June 7, 2023 at 12:46 PM, that there was a passenger, no shirt sleeves and no seat belt, matching the photo recovered by Snap Chat at 12:36 PM

The driver of the Ford Taurus was identified as Patrick A. Scott. Scott admitted to driving JV back to Homer in an interview with Maj Brinson on June 26, 2023, after JVs vehicle was located in Shelbyville on June 26, 2023 during area

searches based on information learned at this time.

I am respectfully requesting a review of the information contained in these reports and a warrant be issued for Patrick A. Scott (DOB:11/25/1964) for Obstruction of Justice (F6), False Informing (A-Mis), Assisting a Criminal (A-Mis), and Contributing to the Delinquency of a Minor (A-Mis) or appropriate action.
