Before me and personally appeared, a law enforcement officer with the St. Johns County Sheriff's Office, and who being duly sworn, states the Defendant SPENCER ROSS PEARSON, did commit the acts stated in the attached Probable Cause Affidavit. **Arrest Warrant - Statement of Probable Cause** Report No. SJSOCHG0006562M

The undersigned certifies and swears that there is probable cause to believe the above-named defendant, who was positively identified by his Florida Driver's License #P625796043000, on the 3rd day of June, 2023, at approximately 4:30  A.M.  P.M. at 150 Valley Circle (Mr. Chubby's Wings), Ponte Vedra Beach, FL, 32080 within St. Johns County, violated the law and did then and there:

Commit the Offense(s) of: Two Counts Attempted Murder - First Degree in Violation of FSS 782.04(1)(a)(1) and Aggravated Battery With a Deadly Weapon Causing Permanent Disability in Violation of FSS 784.045.1(a)(2)

On Saturday, June 3, 2023 at approximately 1630 hours the St. Johns County Sheriff's Communications Center received numerous 911 calls advising a male suspect, Spencer Pearson (Defendant), stabbed several victims in the parking lot of Mr. Chubby's Wings. The complainants stated the Defendant immediately began "steadily" cutting his own throat in an effort to kill himself.

St. Johns County Fire Rescue and deputies responded and discovered three victims with stab wounds, one with life-threatening injuries. One of the victims was a seventeen-year-old female. The defendant was located in close proximity to the victims with self-inflicted life-threatening injuries to his throat. The victims and the defendant were transported to area hospitals for life-saving treatment.

Detectives arrived at the scene and conducted numerous sworn recorded interviews with eyewitnesses. Detectives also reviewed video surveillance from the restaurant. Sworn recorded interviews were also conducted with two of the three victims.

A review of evidence revealed the defendant was previously in \_\_\_\_\_ a juvenile defendant. In April 2023 \_\_\_\_\_ the defendant reportedly began to follow and harass the juvenile victim. On Saturday, June 3, 2023 the juvenile victim and her mother met friends at the restaurant and observed the defendant seated at a nearby table. The juvenile victim and her mother left the restaurant to avoid contact with the defendant. Approximately twenty seconds after leaving the restaurant the defendant was observed charging towards the juvenile victim and her mother as they walked toward their vehicle. In a sworn recorded interview one of the victims stated the defendant held the juvenile victim with one arm and stabbed her approximately fifteen times. The victim's mother attempted to intervene and was stabbed by the defendant in the forehead and leg. A by-stander ran to assist and dislodged the defendant. The by-stander was also stabbed during the confrontation. After being dislodged the defendant sliced his own throat several times telling witnesses he was attempting to kill himself. Two of the victims and the suspect remain hospitalized with an unknown prognosis.

I know this to be true based on interviews with the Defendant, witnesses and other physical and forensic evidence.
