He worked for Larry King from 1984 to July 4, 1986 and during that time his job was to assist in catering and performing various other duties, such as handling clothing, limousine rentals, etc. He stated that he did work the party hosted by Larry King in Dallas, TX, at the Southfork Ranch which included such notables as Sam Pierce, former secretary of HUD. When questioned, Mr. Prysti indicated that Rod Evans, Odell Evans, David Matsen, and Bobby McGuire also accompanied Mr. King on trips frequently. He stated that these individuals had travelled to LA, CA, Chicago, Washington DC, New York, and various other places. He also indicated that Jarrett and Barbara Webb would quite frequently bring their children (foster) to the King residence for parties, etc., however, he stated that he did not ever witness any sexual encounters at these parties. He did state that the above-mentioned individuals were former lovers of Larry King's, and that they were probably teenagers at the time of the encounters.

Other information indicated that during the past several weeks, Larry King has been calling on friends to solicit donations and/or collections for his "hard times." He stated that a church King is affiliated with recently took up a collection for him.. Other information indicated that Casey Randall, now working for the Pacific Grill which was formally the Cafe Carnival, worked for Larry King and was possibly a lover of Larry

King's. Mr. Prysti further stated that a photographer named Andrew Baran travelled quite frequently with Mr. King and took many photos, however, he does not know whether they involved pornographic photos of minors. Prior to ending the conversation with David Prysti, he indicated that the only knowledge he would have would be of the money spent on trips and parties hosted by Larry King. 



Mr. Quinley stated that he first met Larry King in 1985 at a party held at the Omaha Club, during which time Larry King was a member.

When questioned about the alleged incident during which he observed Larry King in bed with two teenage individuals, Mr. Quinley stated that the incident had occurred at a party held at the Twin Towers located very near downtown Omaha. He stated that this party was held sometime in September of 1987, in a penthouse that adjoined Larry King's penthouse. Mr. Quinley stated that his job was to oversee the waiters and the kitchen staff for a party of approximately 250 people. He stated that he thought the party had been held in honor of Larry King's 40th birthday.

Regarding the party itself, Mr. Quinley stated that he did not note anything unusual. He stated that after the party around midnight, he went to Larry King's penthouse and knocked on the door. He stated that there was a small window in the door and that a black male opened the window and, after Mr. Quinley identified himself, the black male let him into the penthouse.

Upon being admitted, Mr. Quinley observed Larry King lying on a round bed wearing a dark colored or navy blue bathrobe. He stated that Larry King was lying on top of the sheets and blanket. He stated that there were two young black males lying on each side of him with pillows behind their backs wearing street clothes. Mr. Quinley went on to state that he felt very uneasy about the situation and that Larry King didn't even acknowledge that he was there. He stated again that he thought it was strange that no one said anything to him. Mr. Quinley indicated that he stayed for several minutes and then left. On the afternoon of the above date was informed that former Omaha Police Chief Bob Wadman had contacted my office. I then contacted Mr. Wadman at his office in Aurora, Illinois. Further, he stated that his reputation had been severely damaged, and that he had been receiving numerous telephone calls from the media. He also stated that this current boss had been receiving telephone calls. Wadman stated that he wasn't able to discuss this case with his boss.

Wadman went on to state that he has had job offers in Kansas City, but that it would not do any good for him to accept a job there, because this "would just follow him to Kansas City." He went on to state that he understood that I was investigating but thought that it was highly inappropriate. He stated that he did not have much respect for me because I did not polygraph the alledged victims.

I then informed Wadman that it was not my function to test them and that I had in fact requested of the committee that they be polygraphed. I informed him that it wasn't up to me to make the final decision whether or not they would be polygraphed. I told Mr. Wadman that I wasn't attempting to judge anyone, but that there were many incidents and allegations that needed to be followed up on. Mr. Wadman then wanted to know if he had to come back here or whether I could go out there. I informed him that I could certainly could come to Aurora if necessary.

Mr. Wadman went on to state that his family is going through a lot of stress over this situation, and also financial stress in that that he has four children, one of which is in medical school and that it is very expensive. He stated that it cost him \$10,000 to battle former Mayor Mike Boyle. He stated that if he loses everything he will forced to retain an attorney.

Mr. Wadman repeated that he "didn't have anything to do with it." When I mentioned the Twin Towers he stated that he did not know where this building was located. I did inform him that I was sure he knew where the Twin Towers is located. After pausing for

several minutes, he then stated that he thought, on at least one occasion, he was in the Twin Towers on a business related matter, and that was the only time. I did tell him the Twin Towers was located between Farnam and Dodge near 30th Street.

The conversation ended with Wadman asking me to call him in a couple of days.

During the day this writer also received information reference Steve Sharretts, a psychiatrist in Omaha, Nebraska, who is also a reserve deputy in Douglas County. It was learned that Mr. Shaerretts had worked with stress training for the Omaha Police Department in the past. It was learned that approximately five years ago Mr. Shaerretts caught Bob Wadman in many lies reference a counseller in the Omaha Public School system who had told Mr. Shaerretts about a young teenage black female attending to Central High School who was a prostitute. Upon hearing the information from the counsellor, Mr. Shaerretts had gone to Bob Wadman to report this information. After a couple of weeks and nothing was heard from Mr. Wadman, the counsellor again contacted Mr. Shaerretts and wanted to know if any action had been taken. Mr. Shaerretts told the counsellor he would check and get back to him shortly. Mr. Shaerretts again contacted Mr. Wadman who told him, "You mind your own business. We'll take

He did ask me several questions reference this investigation, however, I declined to comment on the investigation. He did ask if I would send him a copy of the video tapes of the kids and I responded that I would not. I did share with him the name of Jim Harf and asked him if he could get me whatever background he could on this individual.

Also on the above date my staff did locate a telephone number regarding Dale Craig, telephone 501-888-1910. As of this dictation it has not been verified, however, I do believe this is the same Dale Craig that was mentioned to this writer earlier who is the karate expert residing in Little Rock, Arkansas.

The morning of the above date was spent making telephone calls and working on reports.

During the course of the day this writer contacted Secret Service Agent, Kirby Hutchinson, telephone 221-4671 in Omaha, Nebraska, and asked him if the Secret Service had in fact picked up Larry King the day prior to the breakfast held regarding Kay Orr and President Bush. If so, I was asked whether or not they knew how Larry King had purchased the ticket and what kind of instrument was used to purchase the ticket to the breakfast. Mr. Kirby emphatically informed me that he had never heard that rumor, and that the Secret Service did not have any knowledge of and was not involved with Larry King reference his removal to Springfield, Missouri.

I thanked Mr. Kirby for his time and ended the conversation.

During the course of the afternoon this writer contacted Douglas County Sheriff, Dick Roth, and relayed the following requests to him: I needed the name of the young female who was allegedly renting an apartment from Larry King and was evicted after Larry King allowed other kids to move in; I needed the last name of Anita, who I had gained information on several days earlier. (Please note that her last name is Adams.); I asked that he check out Mike Sullivan, a former employee Firstier; I asked him about Helmuth Dahlke, alleged to be the righthand man for Alan Baer.

Mr. Roth informed me that he knew Mr. Dalhke quite well and that he was another individual who was "way up there."

During the course of the afternoon this writer received information reference an individual who may possibly handle student placement services through the Omaha Public School system reference the foreign exchange student program. This individual's name is Naida Aschanbrunner, Student Placement, Omaha Public Schools, 3215 Cuming Street, Omaha, NE 68131-2024.

Upon conducting research reference the foreign exchange program this writer noted that there is a program called the American

Scandinavian Student Exchange, otherwise known as ASSE. Two individuals involved with that program are Jonothan Davis, telephone number 464-9542, and Susan Schrioer of Bennett, Nebraska, telephone number 782-6973.

Further, there is an agency titled The Swedish Finnish Department of Education that is located at 920 O Street, Lincoln, Nebraska, telephone number 477-5079. There is also an "800" telephone number; 1-800-333-3802.

This is an agency titled The Council on Standards for International Education and Travel, address 1906 Association Drive, Restin, Virginia 22091.

Also, during the late afternoon this writer received a telephone call from Donna Owen indicating that she had some important information that she wanted to share with this writer. She requested that I meet her at the Greenwood Interchange.

After making arrangements with her, we then met at 7:00 PM at the Happy Chef Restaurant located at this interchange. During the course of the conversation she had mentioned two murders, one of which involved an individual identified as Mr. Baker who was shot in the back of the head in South Omaha, and another individual in North Omaha who she did not know the identity of. I informed Mrs. Owen that I was aware of the individual in South Omaha, and that it might be a former police officer who had been Mr. Baker's partner.

Donna also furnished this writer with some information reference a possible victim by the first name of David. She stated I should contact a Ralston High School teacher identified as Mel Melcher, telephone 339-2365, and that this individual has a friend who is also a teacher who counselled a young man several years ago by the first name of David.

Mr. Owen indicated that the young man staying at Peter Citron's residence has been moved to another residence on the same block as Peter Citron's residence, and that he was going to attempt to find out who the individual is. Mrs. Owen stated that another individual's first name is Ingo and who was a foreign exchange student from West Germany. She stated that Ingo attends Central High School and that he is approximately 18 years old. She stated that she had called the superintendent of this school after she had learned from her daughter that Ingo was having a very difficult time in school because he was being harrassed by the other students. She stated that her daughter had told her Ingo had been crying on the above date because of the adverse publicity reference Peter Citron, and because he was being teased by the other students. She indicated that she had called the superintendent of this school reference this individual receiving counselling.

She also stated that when she first called the school the boy had

not received counselling. and that they did not see any need for counselling. She stated that she became quite insistent over the matter and the superintendent then assured her that he would look into it.

At 0720 on the above date this writer arrived at the State Capitol reference a meeting with Senator Schmit and the Franklin Legislative Committee between 0730 and 0800. All of the committee were present, with the exception of Senator Warner. Attorney Pam Vuchetich also arrived for the meeting.

During the course of the meeting there was a discussion reference the three victim/witnesses. There were several news media personnel there, many of them from Channel 6. This writer departed without making a comment.

After departing the capitol at approximately 1100, this writer spent the next hour and a half in my office making telephone calls. I also faxed a letter that I had received from Tyler Gains to Bob Creager reference Harold Andersen. Briefly the letter stated that Mr. Andersen would give a recorded statement, but that his statement would be one indicating that he is innocent. It also stated that he would only give this statement in the event we shared the information reference Mr. Andersen on the video tapes.

This writer then proceeded to Omaha, Nebraska, and contacted Miss Prudy Knowles who is with the Nebraska Childrens Home Society, address 3549 Fontenell Boulevard, Omaha, Nebraska 68104, telephone 402-451-0787. Briefly, Miss Knowles gave this writer some insight to the McChristian kids who were also wards of the state and living in the residence of Jarret and Barbara Webb, just prior to the Webb childrens' involvement in 1982. She went on to relay information reference Joanie Gregory, an employee of the Department of Social Services in Omaha, Nebraska.

Following the interview, Miss Knowles gave this writer a recorded statement.

This writer then proceeded to the Burger King Restaurant located at 52nd & Center Street in Omaha, Nebraska, after making prior arrangements with Joanie Gregory. This writer met her at approximately 5:00 PM and she relayed the following information.

It should be noted that the purpose for meeting with Ms. Gregory was to determine whether she had been asked by the FBI to keep her comments to herself, or to forget any information she had

gained regarding the Webb family.

Miss Gregory related the following:

She stated that in the Spring of 1987 she was given a referral for a home visit which was the reason she contacted Marcy Frezell, who is the sister of Myra Moss and who this writer also happened to be looking for. It is believed that Myra Moss is residing in Atlanta, Georgia. When I asked Joanie about Myra, she indicated that she was surprised that she was residing outside of Nebraska. Ms. Gregory then stated, however, that she really wasn't surprised because of all the events that had occurred.

Joanie went on to state that when she arrived at this residence, she had spoken with Marcy Frezell and her husband, Jim. At that time, they had two of their own children and also Tosha Washington/Webb, one of the foster children that had previously resided at the Webb residence. During this visit Marcy informed Joanie that Tosha had told her she had been transported around the country several times, she thought to Texas and Louisiana. Marcy remembered Texas in particular, and a Republican Convention because one of the children, possibly Tosha, had a book of matches from Texas and that is how the children had known where they were at. Joanie stated she remembered that the children had been exploited sexually in Texas, and she indicated that it was feeling this activity had been occurring for several years.

Joanie indicated that ollowing this meeting she went back and reported the information to her supervisor, Roxanne Sabin, who works with DSS in Lincoln, Nebraska, both by telephone and in writing. She indicated that she heard nothing about the matter after she had reported it. She indicated that Marcy may have heard that Herald Andersen was mentioned as being involved in sexual exploitation that far back reference children.

Further information indicated that she felt the police in Blair, Nebraska were aware of this activity because Marcy had stated that she either telephoned, or was going to telephone, the police.

Other information gained during this interview indicated that Miss Gregory has some knowledge of abuses in the social service system. She cited the example that telephone calls would be made by foster parents to a state employee, and the state employee would then mark it on his/her sheet as a home visit when acutally it was merely a telephone call. She stated that sometimes when a foster parent would be called in, that too would be designated as a home visit.

She stated that I could possibly get an addresss for Mr. and Mrs. Frezell from Carol Stitt in Lincoln, Nebraska. Please note that Ms. Stiff is the head of the Foster Care Review Board.

It should be noted that Joanie Gregory was extremely hesitant about visiting with this writer because she had not asked permission to do so, and she was afraird that she would lose her job.

I thanked Miss Gregory for her time and departed at approximately 1900.

I then telephoned Senator Schmit's office, during which time he stated that he received word from Senator Dave Landis that there was an individual who wanted to pass on some information reference this investigation. Senator Schmit directed me to contact Senator Landis at telephone number 471-2720 and obtain the information.

Upon contacting Senator Landis, I was given the name of Bill Schaffer, telephone number 477-1715.

It was also noted on the above date that Gary Sorgenfrei had returned my telephone call. Also, prior to departing Prudy Knowles' office, this writer had contacted the Student Information Service located at 3215 Cummings, Omaha, Nebraska, and talked to an individual who had advised me that the director, Doctor Ronald Burmood, or his assistant, Mr. Derkhising, would have the information reference foreign exchange students or students being placed in the Omaha school system. He stated that if I did produce a subpoena they would be more than happy to work with me in providing the names of all of the students that had resided in the residence of Peter Citron. This individual went on to state that they may have to go back to the archives if it was not on their computer. I was assured that this information could be gained if I produced the proper documents.

This writer also contacted the Boys Town Police Chief, Jack Swanson. Mr. Swanson indicated that he would be able to meet with me on Thursday at 10:00 AM.

This writer departed at 2130 for Lincoln, Nebraska, and terminated at 2200.

At 8:30 AM on the above date this writer proceeded to Omaha, Nebraska. Upon arriving, I met with Boys Town Police Chief, Jack Swanson, formerly of the Omaha Police Division. A general discussion ensued reference the Franklin matter and also reference Bob Wadman. During the course of the discussion, Mr. Swanson stated that Mr. Wadman had lied on many occasions to many people within the department and that many are aware of this fact. He stated that Mr. Wadman is very "smooth" and quite image conscious. Mr. Swanson indicated that he had a difficult time believing the allegations reference Mr. Wadman's sexual activities, however, he stated that "nothing surprises him anymore".

This writer then made contact with an informant who stated that the District Court Judges were meeting to disqualify themselves due to the fact they may be under investigation reference the Franklin matter. I was advised that Judge Gitnick was at Judge Murphy's residence on the previous evening, and was also suffering extreme stress because of the information that was beginning to surface in reference himself and his activities with children.

At 1400 this writer arrived at the Massachusetts Mutual Insurance Company located at 90th & Dodge, Omaha, Nebraska, and contacted Mr. Joe Barker. Upon arriving, I was led back to his office, during which time Mr. Barker told me that he had talked with the company attorney prior to my arrival because he was somewhat concerned about the Privacy Act and sharing information with this writer. I assured Mr. Barker that I understood his position, however, but that I would subpoena relevant records if necessary.

Mr. Barker then did admit to writing policies for Larry King and his family. He stated that as far as he knew, he handled all of Larry King's life insurance. Mr. Barker stated that he had known Larry King for many years. He was not certain how they met, however, they did share some duties on church committees and possibly several other Boards. He stated that Larry King had three policies; a disability policy worth \$3,000 per month; a total insurance package worth one million dollars per month (\$100,000 in permanent life and \$900,000 in term).

He stated that his wife, Alice, had two policies; one \$250,000 term and a small permanent life policy worth \$25,000. Reference Larry King's son, Prince, he stated that he had a whole life policy.

Further questioning indicated that Larry King took out a maximum loan against his policies in November of 1988 to pay legal fees, and also approximately three months worth of advance premiums. He stated that Larry King's premiums were deducted from a checking account at First Tier in Omaha. He stated that he started writing policies for Larry King and his family in October of 1981.

Mr. Barker stated that prior to the closing of the FCU, Larry had borrowed \$10,000 against his insurance premiums. He stated that a few months after the FCU closed, his insurance had elapsed which was then followed by cancellation. During the time Larry's insurance was in effect, he was making monthly payments of \$452.06 for his policy, \$27.00 a month for the term policy for Alice, and \$105.39 for his disability policy.

When my questioning started to center around social gatherings, Mr. Barker indicated with a nervous gesture that yes, he had been to some social events with Larry King, but that everything was always "on the up and up." He stated that throughout his friendship with Larry, everthing was always "straight" and that he had never seen anything out of the ordinary.

This invesitgator noted that Mr. Barker seemed extremely uneasy while this writer was present. Further investigation will be conducted reference this matter.

This writer then contacted Sheriff Dick Roth at his office in West Omaha and conducted a brief conversation with him, during which time I did thank him for his assistance and support.

This writer then met with a confidential informant for several hours.

This writer then proceeded to Jim Cody's residence, address 10286 Fieldcrest Drive, Omaha, Nebraska, telephone number 392-0678. Mr. Cody's social security number is 270-36-9682 and his license number is G01-022309. His former police department was number 111676, and his FBI number is number 223800JA0. During the course of the evening, Mr. Cody gave this writer information reference his knowledge of activities involving Omaha attorney, Jay Derr. He also gave me information reference his former wife, Sherry Cody, telephone number 397-8019, who had operated a business next to the the FCU and who has knowledge of events regarding children. Jim also stated that his former wife was close friends with an individual identified as Sally who had been employed by the FCU.

I informed Mr. Cody that I would like to take his information

formally, and that if he wanted to check with his attorney, to do so.

Briefly, Mrs. Owen indicated that she received information from an attorney that Alan Baer allegedly had some problems with a security guard at the Twin Towers and that following this misunderstanding the security guard had begun to video tape individuals entering and exiting Alan Baer's apartment. Mrs. Owen ndicated that the FBI had picked up that tape the previous week.

It should be noted that this writer has talked to at least one or two security officers at the Twin Towers and none of them made mention of a video tape that was done by a security officer. I believed the argument between the security officer and Alan Baer

was over the traffic coming in and out of Alan Baer's apartment.

This writer then returned to my office and spent the remainder of the evening dictating notes and reports in preparation for the grand jury.

This writer terminated for the evening at 2100.

I 0930 on the above date this writer began to label photographs and preparating information to remit to the FBI. I also telephoned Senator Schmit's office and advised Lou Reider, his secretary, that reference the tapes that he had furnished this writer, half of them were blank and that I needed the originals to make the copies.

I also received a call from Steve Berry who indicated that World Herald reporters were at his office making inquires reference my background.

This writer and staff member, Karen J. Ormiston, then proceeded to Omaha, Nebraska, to prepare for our 4:00 p.m. meeting with Gary Sorgenfrei.

This writer then gained some information regarding Liability and Delayed Discovery cases in the State of California. I also received information reference an individual by the name of Ehlers who was allegedly part of the original group that went into the FCU the day it was closed. It is not known what this individual's first name is, however, her husband's name is Lee and their residence is located between 38th and 42nd Street in Omaha. I was informed that Mrs. Ehlers had made a comment that there was a large amount pornographic material taken out of the credit union, including videos and photographs depicting sexual acts. I was told that if Ehlers or any of the other people working for the CPA firm that was contracted by the government would say anything, that they would automatically lose their jobs.

This writer and staff member, Karen J. Ormiston, then proceeded to Gary Sorgenfrei's residence. We made four attempts to contact Gary at his residence; at 4:00 pm; 5:00 pm; 5:30 pm; and again at 6:45 p.m. No one was home, however, there was a radio playing in the residence. This writer did leave my business card. It is not known whether or not he deliberately failed to show up, or was at home and the lights were off, or if he forgot about our scheduled meeting.

Upon checking the Omaha telephone directory, staff member, Karen J. Ormiston, had noted one "Ehlers" with the first initial "L" however, no address was listed. The telephone number for this

"Ehlers" is 558-3448.

This writer then proceeded to James and Marcy Frezells's residence located on Florence Boulevard, however no one was at the residence. I did leave my business card. Upon talking with a neighbor, I was informed that someone had moved out of the residence last week but that people were still coming and going at all hours, especially young people. This neighbor stated that he doesn't see these people very often but that have been rather loud at times. I left my business card with this neighbor and he advised that he would telephone me if he saw James or Marcy Frezell at the residence. He stated that Jim may work a swing shift due to the fact that his hours seemed to vary.

This writer then attempted to contact Chris Carmean at his residence, however, he was not home.

This writer returned to Lincoln at approximately 2100.

From 0830 to 1530 on the above date this writer briefed Samuel Van Pelt and his assistant, Terry Donahue.

This writer then proceeded to Omaha, Nebraska and after making prior arrangements interviewed Mr. Steve Sharretts, home address 12742 Cryer Street, Omaha, Nebraska. Upon arriving, Mr. Sharretts indicated that in approximately November of 1985 he had received a call from Stan Malachefski, a counselor from Central High School. He stated that he had called reference a black female identified as Anita Adams, who had related to him that she had been "passed around" in the Omaha area and taken to parties where sexual actitivy occurred. Mr. Sharretts went on to state that a Regional officer from the Omaha Police Department had taken the information. He stated that normally a uniformed officer would take the report, however Regional was interested in this particular matter.

Sharretts went on to state that the initial information was taken at the school, and that they then went over to Anita Adams' residence to finish taking the information. Upon arriving at the Adams' residence, the Regional Officer told Mr. Sharretts that he would take the information privately and that he wasn't allowed to finish up the interview. Sharretts stated that the officer and Anita Adams went to the basement while Sharretts waited upstairs with the mother.

Briefly, Anita Adams stated that a black youth leader from a church in Omaha would pick her up under the auspices of taking her to choir practice, however, she was actually taken to parties in Omaha where sexual activity occurred.

Sharretts indicated that after a few days, he wanted to be sure that Chief Wadman had been informed so he went to him told Chief Wadman about a case that would probably be coming up and he wanted to be sure that Wadman was informed ahead of time. At that time Wadman said he would follow up on it. After a brief time, Mr. Sharretts stated that he again went back to Wadman and asked if anything was being done with this particular case. On this occasion Wadman told him, "Mind your own business. The police would take care of it".

At 1000 on the above date this writer interviewed Mr. A. Stacy Stasenka, address 1131 S.W. 21st Street Court, Lincoln, Nebraska, telephone 476-2707. Briefly, Mr. Stasenka indicated that he had flown for the Games and Parks Commission for many years up until the time the the commission eliminated the airplane service. During the time that he was the pilot for the Game and Parks Commission he had the opportunity to fly Mr. Gene Mahoney, who was the Director of the Games and Parks Commission, back in in the 1970's and early 1980's.

During his time with the Commission, he stated that Eugene Mahoney always travelled with young individuals, i.e. late teen's or early 20's. He stated that one person he would always remember travelling with Eugene Mahoney was Bill Karney, who is now a dentist in Nebraska City, Nebraska. Stasenka indicated that Karney had flown with him while he was working his way through college, and possibly just prior to that.

Another individual he remembers travelling with Gene Mahoney is identified as Mark Dickie, who is now head of Building and Maintenance for the Games and Parks Commission. Bill Swensgo.

He remembers Roger Coons, who is presently the head of Mahoney State Park and an individual who had also travelled with Mahoney during his time period.

He remembers Jim McCallister, who presently is the director of Information and Education for the State of Nebraska.

Stasenka stated that he had flown Mahoney all over the state on numerous trips. He stated that many times they would leave on Friday afternoon and he would drop them off at their destination. He stated that either he would have to wait for them, or he would be allowed to come back home. He stated at no time during his employement as a pilot for Mahoney did he ever witness anything improper, however, he did state that things did seem strange to him. He also stated that he had heard rumors regarding Mahoney's trips and those who accompanied him.

Mr. Stasenka went on to state that whenever Mahoney would travel, especially with his aides, they always had to stay in the same

room or cabin with Mahoney. He stated that on numerous occasions Harold Andersen had also travelled with Mahoney, which may have been to promote the state and the Game and Parks Commission, and also for fund raisers. Stasenka went on to state that if anybody would have information reference Mahoney it would be Bill Karney, the dentist in Nebraska City.

This conversation was recorded.

Tis writer then proceeded to the State Capitol during which time I made several telephone calls, including a call to Carol Stitt's office, Linda Lovgren's office, and to Bonnie Cosentino.

This writer then met with Carol Stitt reference James and Marcy Frezell. I advised her that things seemed rather peculiar at the Frezell residence and that I wanted to get the Frezell's ordered in so that I could interview them without having to go through a long process. Carol Stitt told me that Joseph Nanfito could do that for me.

Bonnie Cosentino also telephoned this writer and informed me that if I wanted to get some insight reference Eugene Mahoney, to go to Dean's Barber Shop located in Omaha, Nebraska. She stated that the people who are employed at the barber shop may have information regarind Mahoney's background.

This writer then had a brief meeting with Senator Schmit. I returned to my office at approximately 1700 during which time I continued preparation for the Grand Jury.

During the course of the afternoon, this writer received a telephone call from Phil Morin, telephone 399-7656. Briefly, he stated that reference Willie Thiesen, there is an individual identified as Ronnie Blankenship who sold drugs and was incarcerated for this activity. Mr. Morin indicated at the present time Mr. Blankenship appeared to be angry at Willie Thiesen and that he may be willing to talk with me.

Mr. Morin further stated that there is an individual by the name of Jimbo Jagusch who resides at 2913 Paddock Plaza, Omaha, Nebraska, telephone 393-5710. He stated that his individual drives a red corvette bearong license Nebraska 1-Tll5.

Mr. Morin stated that Jimbo has a drug and alcohol problem and is very close to Willie Thiesen. He also indicated that he may golf with Willie. Mr. Morin stated that he wasn't sure whether or not he would talk to me but that it was a possibility.

Upon contacting Stacy Stasenka at his residence, he advised me that Jim McCallister had never travelled with Mahoney but thought that he may have some insight into Mahoney's activities. He stated that he thought McCallister got his job because of the influence of McCallister's father.

This writer then returned to my office at approximately 1630.

Upon returning this writer had a message to call Noel Seltzer reference some possible new information involving a female by the name of Janice Moore and an individual by the name of Craig Kennedy. The message indicated that either Janice Moore or Craig Kennedy, both former Franklin Credit Union employees, might have some information reference some knowledge of some photographs. This writer will contact him on Thursday, March 22.

Also, in the afternoon mail on the above date this writer received a letter from Bryan Memorial Hospital addressed to R.J. Nebe reference Troy Boner. Briefly, the letter indicated that Troy Boner had apparently been provided emergency medical care and had listed his employer as Caracorp, Inc. and his occupation as Executive Protection. It should be noted that at no time was he ever employed by either Caracorp, Inc. or Executive Protection, Inc. A copy of this letter will be placed in Mr. Boner's file.

This writer then continued preparation for the Grand Jury. End of report.

Further information from Stasenka indicated that Mark Dickie and Phil Swensgo did not travel with Eugene Mahoney very long because they may have had a falling out. Swensgo is believed to be working with the Games and Parks Commission in maintenance.

He went to state that Mr. Mahoney did like to cater to teenage boys and had participated in many outings with various groups of teenage kids, such as the Boys Scouts.

Briefly, he stated that he had had an experience with a police officer in Dallas, Texas, who had arrested him several years earlier. Mr. Morin also wanted to know if there was anything he could do for me reference any information in the State of Texas. He stated that the police officer may be of some help if there was any information that I may need down there. I advised Mr. Morin I appreciated it and that I would take a look and see if there was was anything I needed to have checked.

Briefly, Alisha is indicating that Kristy Kiaser should remember a party in 1984 around St. Patrick's Day during which both Alisha and Troy were present. The letter also mentions another get together around April/May of 1988 during which time Troy had purchased a marijuana joint from Kristy Kiaser. The note went on to state that this writer should contact Ms. Kiaser so that Alisha's story could be substantiated.

Briefly, the article went on to state that Coleman was demanding money in exchange for Coleman not reporting some "matters" to authorities. It is this writer's probable feeling that Mark Coleman may have, at one time, been involved with Alan Baer and was attempting to get some money out of him reference to some things that Alan Baer may have done to him.

It does not come to any surprise that this has happened in this case, and it would not be surprising if more people would attempt to do the same thing.

It is suggested that Mark B. Coleman be contacted if possible and/ or his family to see if there is anything that he would like to talk to this investigator about reference Baer and/or the ongoing FCU investigation.

At 0830 on the above date this writer continued making copies of video tapes for the Grand Jury.

This writer also received telephone calls from Senator Schmit's office and Bob Creager's office reference subpoenas for the school records regarding Anita Adams; Steve Sharretts; Alisha Owen; Danny King; and Troy Boner. It was decided that the school records regarding Anita Adams and Dr. Steve Sharretts would be ready on the above date for Senator Schmit's. It was decided that the three remaining letters would be remitted to their respective attorneys so that a tentative date could be arranged for their interviews.

During the course of the morning this writer received a phone call from Ron Poskochil, Saunders County Sheriff, Wahoo, Nebraska. Briefly, Mr. Poskochil indicated, upon returning my telephone call regarding Charles Miller, that the evidence, along with the victims came out of Douglas County. The actual activities, however, occurred in Saunders County. He went on to state that he had viewed some of the evidence which contained, he thought, video tapes and photographs. He went on to say that all of the evidence was retained by the Omaha Police Department.

This writer then received a telephone call from Pam Vuchetich's office regarding the desire to return some items to this writer.

Approximately 30 minutes later a representative from her office arrived at the offices of Caracorp, Inc., and returned four video tapes that had been loaned to her earlier. They are listed as follows:

James Daniel King 1 video tape Alisha Owen 2 video tapes Highlights 1 video tape

A receipt was signed by me and a copy was retained for the files.

During the course of the afternoon this writer received a telephone call from Sarpy County Judge, William Staley. Briefly, Judge Staley gave this writer some insight into a former Papillion High

School teacher identified as Heveron who was involved in 1989 incidents with many kids, a large portion of them from Sarpy County. He stated there were many pornographic videos and photos confiscated, along with numerous records and names and places of reference his activities. He also stated that he believes that this case with Heveron was connected with Oak Hills Country Club which is located next to the Millard Airport in the Omaha area. It should be noted that David Prystai is employed by the Oak Hills Country Club.

Judge Staley went on to state that Deputies Jeff Davis, J. Sanderson, Robin Gabriel, and Chief Probation Officer, Ellen Brokofsky, would have information regarding this matter.

I then thanked him for his time and told him that I would be visiting with him in the near future.

Following the conversation with Judge Staley, I then contacted Ellen Brokofsky, Chief Probation Officer in Sarpy County. Briefly, she related information to this writer reference Heveron and how he had manipulated children and made them dress up in Nazi uniforms. She stated that Heveron then video taped them. She stated that a male high school student from Papillion reported to authorities that he had been touched in his genital area while on an outing in Bloomfield, Nebraska. She also stated that many of these children were flown to various places, as Heveron did a lot of traveling.

The most interesting aspect of this matter is that the FBI was aware of this, and Agent Mickey Mont did review the matter. Further, Ms. Brokofsky indicated that there were two Catholic priests identified as Father Pat Henry and Father Fiala who were sexually involved with children in Sarpy County. Both priests were friends of Mike Heveron.

Following the above telephone call this writer, after making several telephone calls, received a telephone call from Linda Lovgren. Briefly, Ms. Lovgren indicated that she had done some editing on a video tape that was made for Franklin USA. The video tape was originally made by Barbara Simon, and was updated by Ms. Lovgren and her staff.

Briefly, Ms. Lovgren indicated that she had worked on a "per job" basis from approximately 1983 through 1987. Ms. Lovgren went on to state that her projects mainly centered around projecting Larry King's image and thoughts to the public. Ms. Lovgren also stated that she had worked on some projects with Jim Harf from Washington, D.C., who is one of Larry King's contacts on the East Coast.

Prior to ending this conversation, Ms. Lovgren stated that she would check her files and produce some records reference her involvement making or editing the tape of Franklin USA. She also stated that she would check to see who may have a copy of that video tape.

This writer then returned a telephone call to Mr. Noel Seltzer at his residence. Briefly, Mr. Seltzer had given me some information reference two former Franklin Credit Union employees, Janice Moore and Craig Kennedy. Noel stated that Janice may have some photographs of Larry King and various young people. He did not know what type of photographs they were and they may be general photographs of various people together. These photographs may be advantageous for identification purposes. Noel also stated that Craig Kennedy, a black male in his mid thirties, would have some insight into Larry King's endeavors and activities while Mr. Kennedy was employed at the FCU.

Seltzer went on to state that Kennedy is now a manager for a Burger King Restaurant in Omaha, Nebraska, however, he was not certain which of the restaurants he is employed at.

This writer continued preparation for the State Grand Jury and terminated at 12:00 AM.

These two individuals are the two foreign exchange students who were registered with the Omaha Public Schools during the past ten years who had stayed at Peter Citron's residence located at 505 South Happy Hollow Boulevard, Omaha, Nebraska.

It is not known at the time of this dictation who the foreign exchange students are who may have stayed with Mr. Citron and were coming from District #66 School District, Millard Public School District, or any private or parochial schools such as Creighton Prep.

It is my understanding that there may have been several students from Creighton Prep who had stayed with Peter Citron.

The information furnished to this writer from Dr. Ronald Burmood was relayed to this writer in a letter dated March 14, 1990, from the Omaha Public Schools and was signed by Dr. Burood, Director.

On the above at approximately 0930 this writer made several telephone calls, one of which was a return telephone cal to Linda Lovgren, owner of Lovgren Advertising Inc., located at Regency Court in Omaha, Nebraska.

This writer also telephoned Ellen Brokofsky, Probation Officer in Papillion, Nebraska. After a brief conversation with Ms. Borkofsky, this writer proceeded to Papillion to visit with Ellen and her boss reference school teacher, Mike Heveron. Due to the heavy amount of snow this writer was delayed for a period of time and arrived in Papillion at approximately 1130.

For approximately the next three hours this writer met with Ellen Brokofsky and her boss regarding the former school teacher. During the course of the conversation she indicated that Mike Heveron had been working for the Oak Hills Country Club and that he was in charge of the dining rooms. She further stated that he had been teaching at Papillion Public Schools for the past 17 years and had quite an extensive "following" of young adults. Also during the course of the conversation, Ms. Brokofsky told this writer that Father Henry, who may be involved with the sexual exploitation of boys, was transferred to Bolivia when child abuse allegations reference child sexual exploitation surfaced in the mid-eighties. Also, Father Henry had at one time been attached to Boys Town.

Ms. Borkofsky also related that a Father Fiala had been transferred two years ago and was shipped out to an unnamed location not known to this writer and then brought back in 1989. Ms. Brokofsky indicated that Father Fiala had undergone psychiatric care, believed to be for sexual abuse. Father Fiala is believed to back at Boys Town at this time.

Other information gained was as follows:

Two Sarpy County boys, one by the name of Michael Hughes, had sex with Alan Baer and also slept with Alan Baer's wife. Brokofsky also indicated that they had counselled a young man by the name of Robert Graves, who also stated he had sex with Alan Baer.

Ms. Brokofsky further indicated that Sheriff Pat Thomas is still sitting on all the evidence in regards to the former teacher, and that arrangements should be made in regards to looking at the evidence. Please note that Pat Thomas' telephone number is (402)-

This writer then proceeded to the Lovgren Advertising Agency picked up a video tape entitled, "Franklin Credit Union: Grand Opening-June 19, 1985." This tape is a Beta-type video tape and I was not able to view it prior to this dictation. A receipt has been signed by this writer reference this Beta tape and will be placed in Ms. Lovgren's file.

This writer then, after several attempts, made contact with Gary Sorgenfrei. We talked for approximately 40 minutes, during which time he stated that he had Sunday and Monday off and would be available to meet Rachel Parker. Please note that Rachel Parker had indicated to this writer by telephone that she would do anything she could to assist in counselling Gary to help him through this situation.

Upon returning to my office in Lincoln, Nebraska, this writer had a short conversation with Donna Owen, after she had left a message to contact her. She indicated that a good friend of hers was told that a prominent individual had witnessed Larry King put some kids on an airplane. Due to the probable wiretapping of the telephones, however, I directed her to contact R.J. Nebe and relate the information to him and then he would, in turn, relay it to this writer.


This writer also returned a telephone call to Kirsten Hallberg. During this conversation she told me that back in May of 1988 she was in Kansas City, during which time she was contacted by an Intelligence Officer of the Anchorage Police Department. They indicated that they wanted more information reference Larry King. In her travel logs located in Omaha, Ms. Hallberg indicated that she couldn't find the name while we were talking, but she would get that information and call this writer back.

Ms. Hallberg went on to state that Robert Olson, who was one of Bob Wadman's closest associates at the OPD, is now the Police Chief in Napierville (sp), Illinois, which is a suburb of Chicago, Illinois.

When asked about Shawnetta Moore, Kirsten stated that Shawnetta informed her that she would rather go to jail than go in front of the grand jury and talk about her past. Ms. Hallberg stated that Shawnetta is extremely afraid of trying to relate what happened to her to so many people. Kirsten did state that her therapist at the present time is a woman by the name of Karen Hacker, who has an office around 94th and Dodge in Omaha, Nebraska.

Further information reference Shawnetta Moore indicated that there are two telephone numbers for her: 402-733-7615 which is Shawnetta's telephone in her bedroom, and 402-734-6769. Kirsten stated that her mother, Bobbie, works at nights.

Other information gained from Kirsten indicated that a freelance



journalist by the name of Wayne Baker, telephone 708-850-3352, who freelances with the Chicago Tribune, was working on a story reference Bob Wadman but his editor had told him that if he made any attempts to do any articles on Bob Wadman he would lose his job. Kirsten went on to state that Baker is still trying to do write an article on his own time reference Bob Wadman.

Kirsten advised me that when calling Shawnetta Moore, to tell Shawnetta that she had purchased a birthday present for Kirsten's son, Michael, this past week and that this statement would indicate to Shawnetta that Kirsten and I had spoken and that the information is indeed legitimate.

This writer terminated for the evening at 2200.
