CARON NAZZARIO, DUANTE WRIGHT, AND PROBABLE CAUSE

- CARON NAZZARIO WAS STOPPED BY WINDSOR, VA POLICE ON DECEMBER 5, 2020
- NAZZARIO IS AN ACTIVE DUTY 2ND LT IN THE US ARMY DRIVING HIS NEW CHEVY TAHOE

- THE INITIAL REASON FOR THE STOP WAS NO LICENSE PLATE
- NAZZARIO DROVE TO A WELL LIT SPOT FOR THE POLICE STOP

[PLAY VIDEO CLIP – NAZZARIO STOP]

- NAZZARIO WAS ULTIMATELY RELEASED AND NEVER CHARGED
- OFFICERS TOLD HIM THEY WOULD FORGET ABOUT EVERYTHING BUT IF HE FILED A COMPLAINT THEY WOULD COME AFTER HIM FOR THE STOP AND MORE
- OFFICER GUITTIEREZ, WHO THREATENED NAZZARIO MULTIPLE TIMES AND PEPPERSPRAYED HIM, WAS FIRED TODAY

THEN IN BROOKLYN CENTER, MINNESOTA, 20 YEAR OLD DUANTE WRIGHT WAS KILLED BY A POLICE OFFICER WHO ACCIDENTALLY USED THEIR GUN INSTEAD OF A TASER

- THE INITIAL STOP WAS FOR AN AIR FRESHNER TREE HANGING FROM THE REAR VIEW MIRROR

- WRIGHT HAD AN OUTSTANDING WARRANT
- WHAT SHOULD HAVE BEEN A ROUTINE TRAFFIC STOP WENT TERRIBLY WRONG

[VIDEO CLIP – BROOKLYN, MN BODYCAM]

- THERE SHOULD BE SERIOUS CONSEQUENCES FOR A MISTAKE THAT ENDS WITH A FATALITY
- POLICE AREN'T SAYING WHAT THE WARRANT WAS FOR
- WRIGHT'S PASSENGER WAS ALSO INJURED
- POLICE AREN'T SAYING EXTENT OF INJURIES

BOTH OF THESE REPRESENT PROBABLE CAUSE STOPS

SUPREME COURT DEFINES PROBABLE CAUSE AS, "where the facts and circumstances within the officers' knowledge, and of which they have reasonably trustworthy information, are sufficient in themselves to warrant a belief by a man of reasonable caution that a crime is being committed."

ONCE NAZZARIO GOT INTO A LIGHTED AREA AND THEY COULD SEE HIS PLATE – THERE WAS NO REASON FOR A FELONY STOP OR ANY OTHER ACTIONS

SHOULD A TREE AIR FRESHNER BE ENOUGH FOR PROBABLE CAUSE?

IT IS ILLEGAL IN MINNESOTA TO HAVE SOMETHING DANGLING FROM THE MIRROR, BUT POLICE HAD NO IDEA WRIGHT HAD A WARRANT UNTIL AFTER THE STOP

FISHING EXPEDITION

POLICE OFFICERS HAVE TO BE HELD TO A HIGHER STANDARD – AND CAN'T PANIC IN THE LINE OF DUTY

NAZZARIO: POLICE ADVISE THAT DRIVING SLOWLY TO A WELL LIT AREA DURING A NIGHTTIME TRAFFIC STOP IS ACCEPTABLE
