FIRST AMENDED INDICTMENT

1 **COUNT TWO – PENAL CODE SECTION 187 MURDER**

2 On or about September 1, 2020 through September 30, 2020, TREZELL WEST and
3 JACQUELINE WEST, did with malice aforethought murder ORSON WEST, a human being, in
4 violation of Penal Code Section 187(a) Second Degree Murder, a felony. It is further alleged
5 that the above offense is a serious felony within the meaning of Penal Code Section 192.7(c)(1)

8 It is further alleged that the defendant TREZELL WEST and JACQUELINE WEST
9 committed a crime that involved great violence, threat of great bodily harm, or other acts
10 disclosing a high degree of cruelty, viciousness, or callousness, with the meaning of California
11 Rules of Court 4.421(a)(1).

14 It is further that the victim ORSON WEST was particularly vulnerable, within the
